

# **Redeemer Fundraisers – Privacy Notice**

**Last updated: September 2026**

Redeemer Fundraisers respects your privacy and is committed to handling your personal information responsibly. This privacy notice explains what information we collect, how we use it and how we protect it.

## **1. Information We Collect**

Redeemer Fundraisers may collect personal information such as your name and email address when you provide your details to us, for example when joining our fundraising community or providing your details at one of our events.

We only collect information that we need for the purposes described below.

## **2. How We Use Your Information**

Contact information is used to communicate with members of our fundraising community and to keep people informed about Redeemer Fundraisers activities.

This may include information about:

- Redeemer Fundraisers meetings;
- upcoming events and activities;
- fundraising initiatives; and
- other relevant Redeemer Fundraisers updates.

We do not sell, rent or share your contact information with third parties for marketing purposes.

## **3. Where Your Information Is Stored**

Contact information is stored securely within the Redeemer Fundraisers Google account. Access to the Google account and the contact information stored within it is restricted to **current members of the Redeemer Fundraisers committee.**

Committee members are expected to treat information accessed through the account confidentially and only use it for legitimate Redeemer Fundraisers purposes.

## **4. Email Communications**

If you have provided your email address to Redeemer Fundraisers for the purpose of receiving updates, we may contact you with relevant fundraising and event information.

If you no longer wish to receive these emails, please contact us at [redeemercepfundraisers@gmail.com](mailto:redeemercepfundraisers@gmail.com) and we will remove your details from our email and update list.

Unsubscribing from our general communications does not affect information that we are required to retain for other purposes, such as records relating to an entry in the Cash Prize Draw.

## **5. Cash Prize Draw Information**

The Redeemer Fundraisers Cash Prize Draw requires the collection and retention of personal information to administer entries, conduct the draws, contact entrants where necessary and distribute prizes.

The information collected for the Cash Prize Draw is kept separately for the purposes of administering the lottery and is subject to the specific requirements outlined in the **Cash Prize Draw Information & Terms**.

For full information about the personal data collected in relation to the Cash Prize Draw, how it is used and how long it is retained, please see **Section 10 – Your Data** of the Cash Prize Draw Information & Terms.

## **6. WhatsApp Group**

Redeemer Fundraisers operates a WhatsApp group for sharing fundraising updates, event information and other relevant communications with members of the group.

Joining the WhatsApp group is entirely voluntary. Members join using the group invitation link or code and can leave the group at any time.

Redeemer Fundraisers does not maintain a separate list of WhatsApp group members. Membership is managed through WhatsApp and reflects the members of the group at any given time.

Please be aware that, as with any WhatsApp group, other members of the group may be able to see your name, profile information and telephone number depending on your WhatsApp privacy settings. Information shared within the group may also be visible to other group members.

## **7. Paper Records**

Where personal information is provided to Redeemer Fundraisers in paper format, the relevant information will be transferred to our secure Google account where required.

Once the information has been accurately recorded and the paper copy is no longer required, the original paper document will be securely destroyed by shredding.

## **8. How Long We Keep Your Information**

We will only retain personal information for as long as it is needed for the purpose for which it was collected, unless we are required to retain it for longer by law or for another legitimate purpose.

Where you have asked us to stop sending general email updates, your details will be removed from our communications list.

Information relating to the Cash Prize Draw will be retained in accordance with the requirements applicable to the administration of the lottery, as set out in the Cash Prize Draw Information & Terms.

## **9. Your Rights**

Under data protection legislation, you have rights in relation to your personal information.

Depending on the circumstances, these may include the right to:

- ask what personal information we hold about you;
- ask us to correct information that is inaccurate or incomplete;
- ask us to delete your information where there is no reason for us to continue holding it;
- object to or restrict certain uses of your information; and
- withdraw your consent where we are relying on consent to process your information.
